Payment for a decision upon examination of a patent application, request for extension of effect of European patent application and European patent, petty patent, topography of integrated circuit, trademark, collective trademark, guarantee trademark, design application, international patent application, international trademark application, application for a deposit and records of subjects of related rights protection, applications for registration of appellation of origin, geographical indication, applications to recognize the right of authorized user of geographical indication, provisional refusal of registration of international trademark: **610.00**

**Tariff no. 119**

Payment for certificates, excerpts from the register and certificates containing data on intellectual property rights being the subject of record of official registration: **1,220.00**

Payment for a copy of a decision on a grant by the body competent for intellectual property matters: **1,220.00**

## **PART A - FEES FOR DOCUMENTS AND ACTS OF BODIES OF THE REPUBLIC OF SERBIA**

### **Tariff no. 1**

Payment for a request, unless otherwise prescribed by this law: **240.00**

### **Tariff no. 2**

Payment for a request for a clarification, explanation, opinion on the implementation of the regulations of the Republic of Serbia an individual: **1,220.00**

Payment for a request for a clarification, explanation, opinion on the implementation of the regulations of the Republic of Serbia legal entity or entrepreneur: **10,000.00**

**NOTE: Fee from this tariff number is not paid for a subsequent communication wherein the obliged person demands faster procedure with regard to the already filed request;**

### **Tariff no. 18**

Payment for an invitation to the obliged person to pay the administrative fee: **210.00**
