

## **A TARIFF OF ADMINISTRATIVE FEES**

### **Trademarks**

#### **Tariff no. 107**

Payment for a trademark application, in particular for:

- 1) up to three classes of international classification of goods and services **12.620**
- 2) each subsequent class exceeding three classes of international classification of goods and services **2.530**
- 3) a figurative element or a verbal sign with a graphical representation **2.530**

Payment for an application for a collective trademark registration, in particular for:

- 1) up to three classes of international classification of goods and services **25.250**
- 2) each subsequent class exceeding three classes of international classification of goods and services **3.790**
- 3) a figurative element or a verbal sign with graphical representation **3.790**

Payment for a request for international registration of a trademark, a design, or an appellation of origin **6.300**

#### **Tariff no. 108**

Payment for a request to divide a trademark application **1.890**

Payment for a divided trademark application, divided trademark applications, for each separate application, in particular for:

- 1) up to three classes of international classification of goods and services **12.620**
- 2) each subsequent class exceeding three classes of international classification of goods and services **2.530**
- 3) a figurative element or a verbal sign with a graphical representation **2.530**

#### **Tariff no. 109**

Payment for the result of examination of patent application, request for extension of effect of European patent application and European patent, petty patent, topography of integrated circuits, trademark, collective trademark, guarantee trademark, design right, international patent application, international trademark application, applications for depositing and

filing the subjects of subject-matters of related rights, applications for registration of an appellation of origin, geographical indication of origin, applications for recognition of the right of authorized user of appellations of origin, applications for recognition of the right of the authorized user of geographical indication of origin, provisional refusal of international trademark registration **630**

**Tariff no. 116**

Payment for grant, maintenance of granted trademark, for a ten year period, in particular for:

- 1) up to three classes of international classification of goods and services **25.250**
- 2) each subsequent class exceeding three classes of international classification of goods and services **3.790**
- 3) a figurative element or a verbal sign with a graphical representation **3.790**

Payment for registration, extension of validity of a collective trademark, guarantee trademark, for a ten year period, in particular for:

- 1) up to three classes of international classification of goods and services **31.550**
- 2) each subsequent class exceeding three classes of international classification of goods and services **3.790**
- 3) a figurative element or a verbal sign with a graphical representation **3.790**

**NOTE:**

Payment of a maintenance fee as specified in this tariff number is due before the beginning of the year wherein begins the subsequent period of protection, and not earlier than six months before the lapse of the period covered by the previous fee.

When the fee specified in the paragraph 1 of this note is not paid before to the beginning of the year when the subsequent period of protection begins, the fee shall be increased by 50%, and it can be paid within six months from the date of the lapse of the period specified in this tariff number.

**Tariff no. 117**

Payment for a request to divide a trademark **1.890**

Payment for a divided trademark, divided trademarks, for each trademark, in particular for:

- 1) up to three classes of international classification of goods and services **25.250**
- 2) each subsequent class exceeding three classes of international classification of goods and services **3.790**

3) a figurative element or a verbal sign with a graphical representation **3.790**

**Tariff no. 119**

Payment for certificates, excerpts from the register and certificates containing data on intellectual property rights being the subject of record of official registration **1.260**

Payment for a copy of a decision on the grant by the body competent for intellectual property matters **1.260**

Payment for certificates on internationally registered trademarks, design, being the subject of record of official registration with the body competent for intellectual property matters **3.150**

**Tariff no. 120**

Payment for a certificate on the right of priority granted for the application filed for an industrial property right, in particular for:

- 1) the first certificate not exceeding ten pages **1.510**
- 2) each subsequent certificate to the same applicant not exceeding ten pages **380**
- 3) each subsequent page exceeding the tenth page **30**

**Tariff no. 121**

Payment for the request for the reestablishment of the rights in the procedure before the body competent for intellectual property matters **3.150**

**Tariff no. 122**

Payment for a request for extension of time limit before the body competent for intellectual property matters, in particular for:

- 1) the first request up to 30 days **1.260**
- 2) each subsequent request for each started month of the extension of time limit **1.890**

**Tariff no. 123**

Payment for a certificate on the grant of industrial property right **2.530**

Payment for a copy of the certificate on the grant of intellectual property right **1.260**

**Tariff no. 124**

Payment for a request for revocation of a trademark due to non-use **25.250**

Payment for a proposal for invalidation of right on granted patent, petty patent, decision on the entry of the extension of European patent in the register of patents, trademarks, internationally registered trademarks **25.250**

**Tariff no. 125**

Payment for a decision made upon a request for entry of the assignment rights, license, security, franchises or other trademark rights, and any right derived from a trademark application, design application, in particular:

- 1) if the request refers to one trademark, application, or design **3.790**
- 2) if the request refers to several trademarks, applications, designs, per each trademark, application, design **2.530**

**Tariff no. 126**

Payment for a decision made upon the request for entry of a change of applied for or granted intellectual property rights, unless the law stipulates otherwise **1.890**

If the request for a decision specified in paragraph 1 of this tariff number refers to several trademarks, several applications for trademark registration, design, per each trademark, trademark application, or design **1.260**

**Tariff no. 127**

Payment for the result of examination in the procedure of maintenance of patent, petty patent, trademark, design rights **630**

**Tariff no. 128**

Payment for a request to take a trademark application, design application, application for registration of appellation of origin, geographical indication of origin, recognition of the right of authorized user of appellation of origin, recognition of the right of authorized user of geographical indication of origin, for an expedited examination **6.300**
